ATTENTION UNIONIZED STATE EMPLOYEES:

SEBAC V. ROWLAND CLASS ACTION LAWSUIT UPDATE

Class counsel has now reached a settlement of the SEBAC lawsuit with the Connecticut Attorney General. The settlement has been approved by the General Assembly.

The Court presiding over the case has also preliminarily approved the settlement and has scheduled a hearing to consider whether to give final approval for the settlement. That hearing will take place on October 1, 2015 at the United States District Court at 450 Main Street, in Hartford.

Class members will receive notice before the hearing – either by mail, email or workplace posting, or through publication in several newspapers throughout Connecticut – which will advise them of the date of the hearing and their rights with respect to the settlement. It is expected that the notices will be mailed, emailed or published on or before August 1, 2015.

WHAT YOU NEED TO DO

To be a class member, you must have been employed by the State of Connecticut and a member of

a bargaining unit (or, if you were under a working test period or training program, designated for membership in a bargaining unit when you completed the test period) as of November 17, 2002.

Class members will receive different compensation from the settlement depending on whether they were laid off from their State employment, bumped to a different position in the State workforce, or suffered some other adverse job consequence as a result of the layoffs.

In addition, all members of bargaining units will be entitled to receive compensation for the chilling of their union membership rights as a result of then-Governor Rowland's targeting of union members for layoff.

We need to make sure that we have accurate information about each class member to make sure that you receive the proper award from the settlement.

Connecticut Pension Plans Earns Finalist Honors In National Hedge Fund Industry Award Competition

Plans Won Award in 2014

HARTFORD, CT – The Connecticut Retirement Plans and Trust Funds (“CRPTF”) has captured finalist honors in Institutional Investor magazine’s 13th annual Hedge Fund Industry Awards. CRPTF was one of four finalists in the category of Large Public Plan of the Year. In 2014, the CRPTF won the award. This year, the Pennsylvania Public School Employees’ Retirement System (“PSERS”) – a repeat nominee from 2014 – won the category. Other nominees were the Canada Pension Plan Investment Board and the Teachers’ Retirement System of the State of Illinois.

The CRPTF is comprised of six State pension plans and nine State trust funds. It invests and safeguards assets held on behalf of the Teachers’ Employees Retirement Fund; State Employees’ Retirement Fund, Connecticut Municipal Employees’ Retirement Fund, and a number of other smaller retirement and trust funds. Connecticut’s hedge fund portfolio stood at \$1.6 billion as of December 31, 2014. In the CRPTF’s most recent fiscal year, ended June 30, 2014, the hedge fund portfolio returned 7.15 percent net of all fees. It outperformed its customized benchmark by 710 basis points during the fiscal year and by 440 basis points annually since the program’s inception.

Institutional Investor magazine is a leading international finance publisher of two magazine editions - Americas and international - with a global circulation of 115,000. Each year, Institutional Investor magazine recognizes public funds that stood out for their performance innovation, achievements and contributions to the industry in the past year. In the Large Public Plan of the Year category, consideration also is given to long-term performance and overall ability to construct and manage a hedge fund portfolio. The nominees are public plans with greater than \$15 billion in assets. The winner, selected by Institutional Investor’s editorial staff, was announced at an awards ceremony in New York City on Thursday, June 25, 2015.

Care 4 Kids Redetermination changes to ONE YEAR!

Finally, the federal and state regulations have increased the length of time between redeterminations. As of July 1, 2015 the rules for Care 4 Kids eligibility allow a family to go one full year instead of eight months before they have to gather pay stubs, complete new applications and submit revised Parent Provider Agreement forms all over again.

If you want to take first aid, child development or English as a Second Language, your first stop is CT Charts-A-Course, the professional development division at the Office of Early Childhood. It’s easy to set up an account with them on-line at www.ctcharts.org. Many Community Colleges offer courses that will get you to a CDA, but act now if you want to pursue any coursework this fall.

If you are interested in enrolling in courses, you should contact your local Community College and CT Charts-A-Course, as Charts-A-Course will help pay for your application fees as well as the classes. Liability Insurance for Family Child Care Providers

SEIU now offers an exclusive membership benefit for family child care providers in our bargaining unit.

The insurance program was created especially for our family child care members; there is no other liability insurance policy for family child care providers like this one in the insurance marketplace. Childcare providers face many different exposures to liability. Providers need to protect themselves and their family’s assets. The Child Care Team at CSEA will soon be launching this program for Connecticut members. In August you will receive notification via e-mail and the United States Postal Service on how to apply for this unique liability insurance through PMI. If your current liability insurance expires before you receive that packet of information, please feel free to contact the Union Hall for instructions.

Were you newly licensed after July 1, 2013?

If you were participating in Care 4 Kids (C4K) before becoming licensed, you may be eligible for contract benefits that reimburse your application fee. You may also be entitled to a \$500 bonus after one-year of being licensed if you still care for a child on the C4K subsidy. If you think you qualify for these benefits, you must take action. 1) Go to the C4K website and download the application for the licensing fee reimbursement. 2) Check the dates on your license to determine if it has been 12 months since date of issue. 3) Once you have been licensed for a year, contact the Office of Early Childhood Licensing Department to request your \$500 bonus. Contact the Union Hall if you experience any difficulty in obtaining your benefits.
